TUITION AND FEES: Tuition \$3000.00 additional costs and fees \$350.00. ServSafe book and test \$150.00. All tuition and fees are subject to change without notice. Current tuition costs may vary by course. For additional information regarding tuition and fees, refer to the current catalog/brochure.

TUITION REFUND POLICY: Refunds: Students may cancel their enrollment within three business days after signing the Enrollment Agreement by notifying the school in writing. Any Applicant who does not begin the course will receive a full refund. Students who withdraw, discontinue, or expelled from the course before the completion of sixty (60) percent of the program will receive a pro-rated refund based on the enrollment agreement, minus ten (10) percent or \$150, whichever is less, consistent with guidelines in NRS 394.449. If a student withdraws or is expelled after the completion after the completion of sixty (60) percent of the program the institution will not refund any money and may charge the entire amount of tuition agreed upon in the enrollment agreement.

If the school does not provide the training as agreed in the enrollment agreement, the school will refund all the money the student has paid or has been paid on behalf of the student.

If a refund is owed, it will be paid within 15 calendar days after the date of enrollment cancellation, termination of the enrollment of the student, last day of an authorized leave of absence if a student fails to return after the period of an authorized absence, or the last day of the student's attendance.

Books, uniforms, educational supplies, or equipment for individual use are not included in the policy for refund. A separate refund will be paid if the student did not use those items. The administrator will resolve disputes on a case-by-case basis and issue refunds as appropriate.



The period of student attendance is measured from the first day of instruction as set forth by the enrollment agreement through the student's last day of actual attendance, regardless of absences. The period for a training program is set forth in the enrollment agreement. Tuition and fees set forth in the enrollment agreement (does not) includes books, uniforms, educational supplies or equipment listed separately from tuition and fees.
